LETTER FROM THE CHAIR



Dear TiE Members,

With each passing day, I can see our commitment of Fostering Entrepreneurship solidifying to firmer grounds globally. As we wrap the year 2019 I wanted to share some remarks.

We recently concluded yet another successful edition of the TiE Global Summit. The 4th edition, hosted by TiE Delhi-NCR, witnessed participation from over 2200 entrepreneurs, industry and corporate leaders, policymakers and the various departments of the Indian government. The two-day conclave explored the theme - Indian Startups, Global Footprint. Our goal with TGS4 was to highlight the factors that have enabled the remarkable success and global expansion of some of the biggest Indian ventures in the past couple of years.

On Day 2 of the summit, we launched TiE Women. This initiative is near and dear to my heart. TiE Women is a dedicated program for women entrepreneurs across the globe. With the motto to Embrace. Engage. Empower., this program is specifically curated to support and mentor women entrepreneurs. This effort is being led by Hemalatha Annamalai as Chair and Dharti Desai as Vice-Chair. I'm happy to announce that we have already received a \$80,000 commitment from a few of our Charter Members. We have also inked a partnership of \$100K with BRTSIF empoWer accelerator for Indian chapters.

Inclusion is an important factor to be implemented in our entrepreneurial community. I'm glad we've taken a step forward in this direction. We've been working on the program for over 6 months now and I'm glad to have been a part of the Core Committee of TiE Women. This comes on the heels of the end of my tenure as a member and Chair of the TiE Global Board. During the past two years, our team has worked hard to launch multiple new programs, including TiE Global Angels, TiE University, TiE India Angels, TiE Women to name a few.



I am very thankful to all my fellow TiE Global board members for their collaboration and support in moving several of the global initiatives forward. I am also thankful to all TiE Presidents and EDs who participated, supported and made all the above initiatives a booming success. I am especially thankful to Vijay Menon, TiE Global Executive Director for his contributions, hard work and partnership in travelling with me far and wide to many chapters to inspire chapters to push forth our impact vision. Thank you to the hardworking staff of Mohini, Aparna and Ben. You made life so much easier for me.

I'm proud that during my tenure we could launch TiE Global Angels in the fall of 2016. Since then, TGA is starting to fly, with so many chapters in the US launching angel investment groups. Also, startups like Hemex Health and Wevo raising large amounts of capital and obtaining mentoring from across the chapter network in the US and India.

The resounding success also paved the way to TiE India Angels. Thank you, Mahavir for your leadership in launching TiE India Angels that will soon spark investment activity across TiE India chapters. I look forward to continuing supporting that program.

I am proud to see that the TYE program now serves as the crown jewel of TiE Global as we plant seeds of entrepreneurship in over 23 chapters and a 1000 students a year. We also piloted a new program, TiE University in 2019 under Paul Lopez's leadership. TiE University aims to encourage entrepreneurs at University/college level. Watch out for more information below.

My parting words are the same as the words I communicated at TiEcon 2017 when I was elected as Vice-Chair of the Board. The Mission and Vision of TiE are to give back and support the next generation of entrepreneurs. But today and for the future, there is tremendous opportunity gap for supporting and mentoring women, youth, and undeserved entrepreneurs in addition to scaling our angel investment activity. We have the three pillars (Youth, Women and Angels) and we have taken key first steps in that direction to lay a strong foundation. I sincerely ask all chapters and the incoming board to keep the flame burning at all fronts on these pillars and stay focused on them. Execution of these initiatives will continue to make us relevant and impactful for entrepreneurs locally and globally.



TiE India Angels

To enhance our commitment to budding entrepreneurs in India, TiE Global launched a pan-India Angel network - TiE India Angels (TIA).

After the launch, TiE Global Vice-Chair, Mahavir Sharma and TiE Global ED, Vijay Menon visited multiple Chapters in India to evangelise TIA, and to interact with Charter Members and members. They visited and met the Chapter leaders of Nagpur, Pune, Hubli, Bhubaneshwar, Lucknow, TiE UP, Bangalore, Delhi, Mysore, Hyderabad, and Kolkata, during the 10-day TiE Chapter Yatra.

Eligibility:

- All CMs have the option to be a part of the TIA and can co-invest locally and pan-India unless they refuse to be part of or don't sign the consent form.
- The Charter Members will have no minimum commitment.
- Participation is voluntary, and once registered as an investor with TIA, Charter Members will get a chance to participate in Chapter-level startup funding. They will also have an opportunity to invest in the national-level deals curated by other TiE chapters.

Strengthen chapters commitment to early-stage and idea-stage startups. The TiE India Angels will not only help these young startups but will also allow Charter Members to learn about Angel investing, trending domains, and investment trends.

Project AIRSWEEE is TiE Global's initiative, focused on Women Entrepreneurs. The program is in partnership with the U.S. Embassy, New Delhi and Consulates.

AIRSWEEE is aimed to unleash value creation amongst aspiring young women in tier-2 and tier-3 cities in India. So far the program has created an impact on about 575 women entrepreneurs in 125+ tier-2 and tier-3 cities in India.

Zaiba Sarang Founder & CEO, iThink Logistics In 2019, AIRSWEEE launched two follow-on programs - ScaleUp and Global Fellows. Both the programs were funded by a US State Department Grant executed through the US Mission in India.

ScaleUp was a four-month mentoring program which included shadowing matched domain leaders for over 100 hours each.

To conclude the program a 3-day Women's Entrepreneurs Conclave was organised in October, in Delhi. Titled – Scaling New Heights, WEC 3.0 hosted 30 women entrepreneurs that graduated from ScaleUp Fellowship. It included knowledge sessions for scaling up businesses by leading U.S. and India-based domain experts. The event saw former DPIIT Secretary, Ramesh Abhishek and Counselor for Cultural Affairs, US Embassy, New Delhi, Conrad Turner, among others. On the final day, the 30 fellows were awarded certificates by David Kennedy, Minister Counselor for Public Affairs, US Embassy, New Delhi.

Additionally, TiE Global announced AIRSWEEE Global Fellowships, an innovative program through which 3 selected Global Fellows traveled to the U.S. in December 2019 and "Shadowed" US-based entrepreneurs for a period of 10 days to learn best practices and network with entrepreneurs in the USA. They also got an opportunity to promote business practices exchange between India & the USA. The trio was mentored by Jarrett Streebin, Co-founder, EasyPost and Mani Krishnan, Founder, Shastha Foods


TiE Global announced the launch of TiE Women to promote women entrepreneurs across its 61 chapters globally. The initiative kick-started with a fundraise of USD 80,000 contributed by TiE Charter Members during the two-day event.

The vision and goal of TiE Women are to "Embrace.Engage.Empower." women entrepreneurs across the globe – irrespective of the size, origin, interests, standing and background, of the enterprise. This will be done through sustainable and easy-to-adopt programming that will track the entire entrepreneurial journey with measurable metrics.

Hemalatha Annamalai, Founder, Ampere Vehicles Ltd., and President TiE Coimbatore, will be the Chair for TiE Women. Dharti Desai, Vice President, TiE New York, will be the Vice-Chair for TiE Women. The program will culminate in an annual mega event where the chapter winners will showcase their successes and get access to funds, scholarships, accelerators, and more. The program will mentor women entrepreneurs about funding, scaling the business, etc.

TiE Women's program approach will build upon best practices from local chapters' women-centric initiatives. This will specifically result in capacity building; increased networking, knowledge-sharing and visibility; and a 'safe space' for women entrepreneurs to learn without inhibitions and judgment. This will also maximize the potential of women business leaders to receive funding to grow their enterprises.

CM Retreat @ Dubrovnik















